- Grants He stated that he has submitted the grant report for the Yocha dehe grant for \$147,000. He is also working on completing the report for the repurposing of the \$88,000 grant from Yolo County.
- AC Heins reported that our new Fire Lieutenant, Scott Bravo, has been well
 received by all members. He said that Scott is very welcoming, eager to assist
 and has a great attitude. He informed the Board that many Volunteers have been

stopping by and spending time training and working Duty Shifts.

- Injured employee update AC Heins informed the board that the injured employee has had surgery and is scheduled to come back to limited duty on December 8.
- Self-Contained Breathing Apparatus Fit Testing AC Heins told the Board that Chief Rita was to present a proposal, to the Fire Chiefs, to partner with YCPARMIA for a new fit test machine. If accepted it would reduce the time needed to complete the testing and meet the recognized standards.
- New Payroll Company AC Heins informed the Board that the County has contracted with a new payroll company. He will be training on the new system sometime in December for a January implementation.
- Local Roads Planning Project AC Heins informed the Board that he was asked to sit on the Yolo County Local Roads Planning Project as a Fire Department Representative. The Board felt that this was worthwhile and that after consulting with Chief Rita he should participate.
- Sacred Oaks AC Heins informed the Board that the next meeting for the Sacred Oaks project will be in early December.
